## DO I REALLY NEED MULTIPLE CAMERA OPERATORS?

Having multiple camera operators allows us to place ourselves around strategically to capture things as they happen naturally. We also make use of telephoto lenses to remove ourselves physically from the action and capture things intimately from afar. We do our best to make ourselves inconspicuous to your guests.

### DO YOU ACCEPT PAYMENT PLANS?

Upon electronically signing your official wedding contact, a nonrefundable retainer fee of  $\frac{1000}{1000}$  will be due. The remaining balance will be due 2 weeks prior to your wedding date.

### WHAT FORMS OF PAYMENTS DO YOU ACCEPT?

### **ARE THERE ADDITIONAL FEES?**

All taxes are inclusive with our pricing. If you wish to use is PayPal for your payment there is a 2.9% fee that will not go towards your final balance due.

## WHAT TIME DO YOU SHOW UP TO START FILIMING?

In most cases we show up 2 hours before the Bride is scheduled to get into her wedding dress. That is when your 8-10 hours of coverage will start.

## CAN WE SELECT THE MUSIC OVERLAY FOR OUR CINEMATOGRAPHY PACKAGE?

Music choice sets the overall tone of your wedding highlight and how it will edited (ballad vs. up-beat music). Our creative team decides the music for the teaser clips, but are open to suggestions for your other videos.

Since we upload your highlight reel onto Vimeo & YouTube for easier sharing with your family and friends, they have very strict copyright rules that forbid us from using most mainstream music without paying for an extra license. From the list of requested songs we receive from you, we try to use a different version, a cover song, or a song of similar style and feel.

### WHAT TYPE OF EQUIPMENT DO YOU USE?

We use HD & 4K DSLR type cameras.
